### Public Notice

The DGDE, Ministry of Defence, Govt. of India vide letter No. 76/67/PWM Rules/C/DE/2022 dated 30<sup>th</sup> June, 2022 and Directorate Defence Estates, Western Command letter No. 4/927/Swachh Surveskshan/Cantt/DE/WC/RMS/- dated 30 June, 2022 has issued directions under PWM (Amendment) Rules, 2021 on 12-08-2021 vide which:-

The manufacturer, import, stocking, distribution, sale and use of following Single use Plastic including polystyrene and expanded polystyrene, commodities shall be prohibited with effect from the 1<sup>st</sup> July, 2022:-

(a) ear buds with plastic sticks, plastic sticks for balloons, plastic flags, candy sticks, ice cream sticks, polystyrene (Thermocol) for decoration;

(b) Plates, cups, glasses, cutlery such as forks, spoons, straw, trays, wrapping or packing films around sweet boxes, invitation cards and cigarette packets, plastic or PVC banners less than 100 micron, stirrers.

The action under sub section (5) of Section 289 of the Cantonment Act, 2006 separately apart from exercising functions under the provisions of PWM, 2016 as amended on 12-08-2021 and MoHUA guidelines, which is reproduced as under:-

“Whoever in a Cantonment manufactures, supplies, carries or uses for packaging or any other purposes material of non-biodegradable nature including polythene bags shall be punished with fine which may extend to five thousand rupees or imprisonment which may extend to six months”

All the residents of Dagshai Cantonment are therefore advised to follow the above guidelines in letter and spirit. Anybody found responsible to avoid these instruction shall be punished as per provision given here above.
