E-Tenders were invited for providing skilled/unskilled manpower at Cantt Board Dagshai for providing various services from registered outsource agencies vide tender notice No. CBD/1/5/Contract/-2320 dated 12-10-2020. In response, 22 bids were received out of which 03 bidders quoted the same rates with a profit margin of 0.01 percent.

In this context tender were re-invited with a clause.

"If same rate is received by the bidders then the Cantonment Board will distribute the work (Cost) equally among the bidders who quoted the lowest bid and same rate. Minimum bid should start from 0.20 % less than 0.20% quoted bid will be considered as rejected" to minimize the same bids from the bidders."

The tenders were re-invited again vide tender notice No. CBD/1/5/Contract/-2523 dated 07-12-2020. This time 21 bids received out of which 09 bidders quoted the same rates i.e. 0.20 percent with a profit margin.

Since it is not possible to award the contract to 09 contractors proportionately.
