The Govt. of India, Ministry of Defence vide No. 14(8)/2019-D(Q&C) dated 04-08-2020 has conveyed the sanction to extend the term of office of all Elected Members of 56 Cantonment Boards including Dagshai upto period of 06 months beyond 10-08-2020 or till the date of constitution of the Board whichever is earlier.

As per section 20 (1) of Cantonments Act, 2006 the term of office of a Vice – President shall be five years or his residual term of office as a member, whichever is less. Sh. Chitranjan Syal, Vice-President Cantonment Board Dagshai has completed five years.
