In this connection public notice was published in the newspaper "Amar Ujala" on 06-08-2022 for inviting any objection to the proposed mutation entries in the record of the Board and also displayed on the notice Boards in Cantonment area but no objection received within 30 days from the issue of public notice.

The relevant file alongwith office report to the effect that there is no unauthorised construction, no change of purpose, no sub-division of site and no encroachment involved in the said holding is placed on the table.

47. COMPOSITION ON UNAUTHORIZED CONSTRUCTION IN RESPECT OF HOUSE & SHOP NO. 49, 49-A, COMPRISING GLR SY NO. 124/139 UNDER THE PROVISION OF SECTION 248 (1) OF THE CANTONMENTS ACT 2006, SADAR BAZAR, DAGSHAI CANTT.

To consider the application dated 15-09-2022 received from Sh. Hiskial Rawat General Power of Attorney (GPA) Sh. Shiv Raj Bharati S/o Sh. Mohal Lal Kaushal for composition of unauthorized construction under the provision of Section 248 (1) of the Cantonments Act, 2006 in respect of House & Shop No. 49, 49-A, Comprising GLR Sy No. 124/139. As per GLR record

above mentioned property classified as B-3 under the management of Cantonment Board is held on old grant terms by Sh. Shiv Raj Bharati S/o Sh. Mohal Lal Kaushal. The property is situated at Sadar Bazar Dagshai Cantt within notified civil area. The cost of unauthorized construction is worked out to sum of Rs. 124212/-. As per CBR No. 53 dated 21-10-1999 the cost of construction of unauthorized construction will be Rs. 24842/- i.e. 20% of Rs. 124212/-.

The relevant file alongwith detailed office report is placed on the table.

RESOLUTION NO.47

Deferred. In this connection the PCB desired that photographs of the unauthorized construction be put up in the next Board meeting for consideration.

48. REVENUE GENERATING AND PUBLIC UTILITY PROJECTS ON OPTIMUM UTILIZATION OF CLASS 'C' VACANT LAND UNDER THE MANAGEMENT OF CANTONMENT BOARDS

Reference Principal Director, Defence Estates, Western Command Chandigarh letter No. 30/Revenue Generation/C/DE/WC/RMS: 31563 dated 20-09-2022.

As per directions of the DGDE, New Delhi and Directorate Defence Estates, Western Command the Cantonment Board Dagshai has already identified the following class 'C' vacant land under the management of Cantt Board for revenue generation and public utility project.

It is mentioned here that in respect of Sy No. 95-C measuring 1.17 Acres, under the authority of CBR No. 57 dated 29-09-2005 the proposal was submitted for construction of Guest House including development of existing approach path by converting the same into motorable road comprising GLR Sy No. 3, classified as Class 'C' land amounting to Rs. 34,29,300/- vide letter dated 15-06-2006. In this connection the proposal was also submitted vide letter dated 15-06-2006 through DEO Ambala for obtaining necessary sanction of the competent authority regarding change of purpose of Sy No. 95-C.

The subject proposal was examined and Dte, DE WC vide letter No. 30/SC/Dag/DE dated 19-07-2006 intimated that the Cantt Board Dagshai is heavily state aided and always depends on grant-in-aid to meet the expenditure of pay and allowances of the Cantt Board employees. There is also huge amount of arrears outstanding against the Cantt Board to be paid to MES on account of water charges. Moreover, the site as proposed by the Board for subject project is for the purpose of incinerator 1, 2, 3 & 4 rubbish destructor and therefore, the sanction of the Govt. is required first for change of purpose and further intimated that the proposal cannot be considered till the sanction of the Govt. is not received for change of purpose. The sanction of the competent authority for change of purpose is still awaited.

In the year 2013 the Board vide CBR No. 9 dated 25-04-2013 has again considered and approved the sites comprising GLR Sy No. 95-C, classified as class 'C' for school building and Adm Block etc, Sy No. 116, classified as B-4 for play ground, hostels, residential quarters for staff and other allied facilities and Sy No. 3, classified as class 'C' for development of existing approach path by converting the same into motorable road. Accordingly, the proposal was submitted vide letter dated 17-06-2013 for obtaining necessary sanction of Govt. for change of purpose of Sy No. 95-C and the Station HQ Kasauli was also requested vide letter dated 17-06-2013 for issuing "No Objection Certificate" from land point of view for the reclassification of 2.0 Acers piece of land out of Sy No. 116 i.e. from B-4 to 'C' for the establishment of residential school at Dagshai Cantt. However, the subject proposal could not finalize so far.

In respect of Sy No. 124-190 the Board vide CBR No. 93 dated 28-02-2018 resolved to construct community hall at a place opposite Sanatan Dharam Mandir near Cantt Board Dispensary Comprising GLR Sy No. 124-190 (part) classified as C land, Sadar Bazar Dagshai. Accordingly, estimates, drawing and structural design was got prepared from the Archiect/Draftsman for execution out of proceeds of service charges after obtaining necessary sanction of GOC-in-C, Western Command. In this regard budget provision was also made for the relevant financial year but during the budget presentation the GOC-in-C did not accept the proposal and said that the Dagshai is small town and Board cannot afford such huge amount on construction of community hall.

As per directions of the Dte, DE, WC regarding optimum utilization of class 'C' vacant land, the CEO Ambala has already invited Expression of Interest (EOI) from the experienced architects, consultants and firms by publishing public notice in the Newspaper "Amar Ujala" on 08-10-2022 for all the Cantonments in Western Command.

In view of the above to decide further action in the matter regarding optimum utilization of class 'C' vacant land as mentioned above. The relevant file is placed on the table.

RESOLUTION NO.48

The Board considered. The Board noticed that Dagshai Cantonment is heavily state aided and depends on Grant-in-aid from the Central Govt. The Board should explore all possibility to increase its revenue by constructing revenue generating and public utility projects on optimum utilization of Class 'C' vacant land under the management of Cantonment Board.

After detailed discussion the Board observed that the site comprising GLR Sy No. 95-C, measuring 1.17 Ac is only suitable for construction of Guest House building, parking, area for future expansion including development of existing approach path by converting the same into motorable road comprising GLR Sy No. 3, classified as 'C'. As per GLR record the purpose of said site i.e. Sy No. 95-C is for Incinerator 1, 2, 3 & 4 and Rubbish Destructor No. 1 & 2 and litter shed and involves change of purpose which requires sanction of the competent authority.

Further the site comprising GLR Sy No. 124-190 (part) situated opposite to Sanatan Dharam Temple in Sadar Bazar area is suitable for construction of community hall. An area of 234.74 sqm is required for said purpose for which drawing has already been prepared by the architect/draftsman. As per GLR record the purpose of said site is for Cantt General Hospital & Building and the site also involves change of purpose for construction of community hall which requires sanction of the competent authority.

After deliberation the Board resolved that proposal be submitted to the Dte, DE, WC in respect of Sy No. 95-C and 124-190 (part) for obtaining sanction of the DGDE New Delhi as regard to change of purpose mentioned above. The outcome of the EOI be also obtained from the CEO Ambala as regard to optimum utilization of class 'C' vacant land as mentioned in agenda side.
