## 5. GRANT OF DEARNESS ALLOWANCE TO CANTONMENT BOARD EMPLOYEES W.E.F 01-04-2024.

To consider the matter regarding grant of dearness allowance to Cantonment Board employees at the enhanced rate from the existing rate of 34% to 38% of pay w.e.f. 01-04-2024 as sanctioned by the HP State Govt. to their employees vide letter No. Fin(C)-B (7)-2/2021 dated 02-03-2024. As per para 14 of the Memorandum of settlement the Cantonment Board employees are also entitled for the payment of additional Dearness allowance at par with the HP State Govt. employees. The additional Dearness allowance of 4% shall be paid in cash with salary of April, 2024, payable in May, 2024 and the arrears

accrued from 01-07-2022 shall be paid in the manner as may be prescribed on this account by separate orders.

There will be an expenditure of Rs. 60,000/- P.M. w.e.f. 01-07-2022. The Budget provision has already been made in the relevant heads of the Budget estimates for 2024-25 (O).

The HP Govt. notification along with relevant file is placed on the table.

#### **RESOLUTION NO. 5**

Now in this regard MoD vide letter No. 11013/2/2016/D(Lands) dated 30-01-2024 has conveyed that the applicability of the interim policy issued vide MoD letter of 11013/2/2016/D(Lands) dated 10.03.2017 as amended time to time has been extended beyond 31.12.2023 for one year or till finalization of comprehensive lease policy, whichever is earlier, to deal with the issue of extension/renewal of expired/expiring leases of defence land granted under Cantonment Codes, 1899 & 1912 and CLAR, 1925 & 1937.

The Board vide CBR No. 16 dated 18-04-2023 has approved the extension of lease in respect of House No. 23, 23-A & Shop No. 23-B Comprising GLR Sy No 124/172, Measuring 1558 sqft situated at Sadar Bazar Dagshai Cantt under the management of Cantt Board upto 31-12-2023.

Now in this regard MoD vide letter No. 11013/2/2016/D(Lands) dated 30-01-2024 has conveyed that the applicability of the interim policy issued vide MoD letter of 11013/2/2016/D(Lands) dated 10.03.2017 as amended time to time has been extended beyond
