The Budget Estimates for 2024-25 (R) provides seeking ordinary grant-in-aid of Rs.6,80,62,967/- only from Govt. & tentatively Rs.7,35,38,596/- only for 2025-26 (O) only.

The expenditure provided under the Heads of the Budget Estimates is more than the average/actual expenditure during the past three years and during the year 2023-2024. Reasons for such increase in expenditure are as under: -

- 1. Payment of annual increments
- 2. Revision of rates of D.A. w.e.f. 01-01-2022 as per H.P. Govt. employees.
- 3. General increase in prices of commodities during the year.
- 4. Payment of arrear of revision of pay scales w.e.f. 01-01-2016 to Cantt Board employee.
- 5. Payment of water charges to M.E.S.
- 6. Grant of pensionery benefits to four employees who will retire during 2024-25& 2025-26.
- 7. Provision made in order to improve maintenance of Cantt Fund properties, roads and to provide better civic amenities.

Budgeting on the basis of average expenditure incurred during the past three year has become out method on account of:-

- (a) General rises in prices of commodities;
- (b) There exists back-log of maintenance which has to be catered for. Any retrenchment under repair and maintenance will only contribute deterioration of the civic condition. The amount reflected for maintenance of Cantt Fund building/roads/drains/ Nallah/other Misc. public improvement etc are the barest minimum.

The Budget Estimates have been prepared with only the absolute essential requirement in mind, thus leaving no margin for any reduction in expenditure. Any further reduction in expenditure will impair the efficiency of the Cantonment Administration. On other hand every effort has been made to increase the income.

The Cantonment Board has been stated-aided since its inception. The main reason for deficit is that the income of the Cantonment Board from local source is very limited and where as the expenditure on establishment and other civil amenities have been manifold. The monthly wages bill cost to Rs. 30.00 lacs and pension bill are Rs. 12 lacs p.m.

The budget estimates are submitted for approval for submission to Govt. of India for acceptance of provision and release of due ordinary grant-in-aid.

RESOLUTION NO. 14

Considered. The Budget estimates alongwith store list for 2024-25 (Revised) and 2025-26 (Original) alongwith relevant documents as placed on the table are approved. RESOLUTION NO. 15

The Board considered. The Board observed that in r/o Stall No. 1 mentioned in agenda side notices for e-auction were issued four times vide notice dated 23-10-2023, 04-12-2023, 20-01-2024 and 30-01-2024 but none has participated. Thereafter the matter was placed before the Board in its meeting held on 26-04-2024. The Board vide CBR No. 6 dated 26-04-2024 resolved that since no bidder turned online therefore auction of Stall No. 1 (Chicken Stall) may be done offline in open auction. The open auction held on 05-06-2024 and Sh. Rajesh Kumar has offered the highest bid of Rs. 5000/- p.a.

Similarly in r/o Stall No. 2 notices for e-auction were issued eight times but none has participated. Thereafter open auction held on 05-06-2024 and Sh. Paramjit has offered the highest bid of Rs. 4000/- p.a.

A total of 132 bids was received for providing outsourcing of manpower services when technical bids were opened on 11-03-2024. Two days time was given to bidders who did not complete the formalities to complete the codal formalities if any. No bidder has registered any of the above formalities within the stipulated period. After this process 66 bids have been found in order and they qualify for inclusion in financial bid. The financial bid opened on 16-03-2024 and M/s Aspirant Manpower Service Private Limited, F/F B-77, JJ Colony, Dada Dev Colony, Palam Village, New Delhi -110045 has quoted the lowest price of Rs. 6331365.19and is L-1 in financial bid.

Accordingly, the matter was circulated among the members of the Board vide Circular agenda No. CBD/7/1/-282 dated 21-03-2024 for consideration and approval of lowest bid. The said circular agenda was also noted by the Board vide CBR No. 04 dated 26-04-2024. Due to the Model Code of Conduct the contract of above firm could not be finalized and awarded without prior approval of the commission and the Board resolved to extend the existing contractor M/s Sunrise Facilitators Pvt Ltd till the above fresh contract is not finalized.

The matter was also submitted to the Chief Secretary, Govt. of Himachal Pradesh Shimla through Distt Election Officer, Distt Solan vide letter dated 04-04-2024 with a request to entrust the said proposal relating to the permission/clarification in connection with Lok Sabha Election 2024 to the screening committee for examination and to obtain the necessary permission of the Election Commissioner of India through proper channel but no response so far.

The Board vide CBR No. 45 dated 05-07-2023 has approved the extension of lease in respect of House & Shop No. 117, 117A Comprising GLR Sy No 124/199, Measuring 402 sqft situated at Sadar Bazar Dagshai Cantt under the management of Cantt Board upto 31-12-2023.

Now in this regard MoD vide letter No. 11013/2/2016/D(Lands) dated 30-01-2024 has conveyed that the applicability of the interim policy issued vide MoD letter of 11013/2/2016/D(Lands) dated 10.03.2017 as amended time to time has been extended beyond 31.12.2023 for one year or till finalization of comprehensive lease policy, whichever is earlier, to deal with the issue of extension/renewal of expired/expiring leases of defence land granted under Cantonment Codes, 1899 & 1912 and CLAR, 1925 & 1937.

Prem Dass in r/o said lease property.
