

EXPRESSION OF INTEREST (EOI)

For Preparation of Detailed Project Report (DPR) for Setting up Modular Sewage Treatment Plants (STPs) in Dagshai Cantonment

1. Introduction

The Cantonment Board, Dagshai intends to engage a qualified and experienced consultancy firm for preparation of a **Detailed Project Report (DPR)** for setting up **modular Sewage Treatment Plants (STPs)** in Dagshai Cantonment, catering to an approximate population of **1,200 persons**.

2. Scope of Work

The selected firm shall be responsible for:

- Conducting survey and assessment of existing sewerage and drainage systems.
- Designing suitable modular STP(s) based on population, flow projections, and site conditions.
- Preparing layout plans, process flow diagrams, and detailed design calculations.
- Estimating project cost including civil, mechanical, and electrical components.
- Providing operation and maintenance guidelines.
- Recommending suitable technologies keeping in view terrain, space constraints, and environmental regulations.
- Assisting the Board in obtaining necessary statutory clearances, if required.

3. Estimated Cost

The estimated cost for preparation of the DPR is **₹2,00,000/- (Rupees Two Lakhs only)**.

4. Eligibility Criteria

Firms intending to participate must fulfill the following conditions:

1. The firm should have at least **3 years of experience** in preparation of DPRs and design of sewage treatment systems.
2. The firm should have prepared at least **one (01)** DPR or completed consultancy assignments for STPs of capacity not less than **0.5 MLD** during the last three years.
3. The firm should have qualified professionals such as Environmental Engineers, Civil Engineers, and Wastewater Experts on its team.
4. The firm should be registered with appropriate Government/Statutory Authorities.
5. The firm should not have been blacklisted by any Government or Semi-Government organization.

Supporting documents such as copies of work orders, completion certificates, firm registration, and team CVs shall be submitted along with the technical proposal.

5. Submission of Bids

Interested and eligible firms are invited to submit their proposals in **two separate sealed covers** as follows:

- **Cover-I: Technical Bid** — containing company profile, eligibility documents, methodology, and past experience.
- **Cover-II: Financial Bid** — containing the consultancy fee for preparation of the DPR.

Both covers shall be placed in a single outer envelope superscribed **“Expression of Interest for Preparation of DPR for Modular STPs in Dagshai Cantonment”** and addressed to:

- **Stage II:** Financial evaluation of technically qualified bidders.
