70. DEARNESS ALLOWANCE RATES FOR NPS SUBSCRIPTION TO CANTONMENT BOARD EMPLOYEES

To consider GoI, Min. of Finance, Department of Expenditure, New Delhi letter No. 1/4/(i)/2025-E.II(B) dated 06-10-2025 vide which the Central Govt. has revised the rates of Dearness Allowance to central Govt. employees from 55% to 58% of the basic pay w.e.f 01-07-2025.

The HP State Govt. Notification No. Fin(C)-B (7)-1/2021 dated 10-10-2024 vide which the Govt. of Himachal Pradesh observed that employees who were still subscribing to NPS regime were suffering a loss with respect to their future Pensionary benefits due to the differential of

Dearness Allowance rates of Central Govt. with that of the State Govt. Hence, it has been decided that for all NPS subscribing employees the Dearness Allowance would be admissible at the Govt. of India rates from the applicable dates and as amended from time to time.

As per para 14 of the Memorandum of settlement the NPS Cantonment Board employees are also entitled for the payment of Dearness allowance at par with the HP State Govt. employees at the Govt. of India rates from the applicable dates and as amended from time to time.

There will be an extra expenditure of Rs. 9000/- P.M. Approx. w.e.f. 01-07-2025 for the payment of DA at the Govt. of India rates i.e. 58%. The Budget provision has already been made in the relevant heads of the Budget estimates for 2025-26 (R).

RESOLUTION NO. 70

The Board considered and resolved that the Dearness Allowance w.e.f. 01-07-2025 from 55% to 58% of pay be made applicable to NPS subscribing employees of Cantt Board Dagshai at the Govt. of India rates. The Board further resolved that the proposal be submitted to the General Officer Commanding in Chief, Western Command for obtaining necessary sanction.
